FEE SCHEDULE

The State of Texas Government Code Ann. § 406.024 sets out the maximum fees a Notary Public may charge for notary public services. The table below list each notarial act and the state fee.

NOTARY SERVICES

First notarial act	\$6
Each additional signature of each individual	\$1
Administering an oath or affirmation	\$6
Certified Copy (copies not included, must be made by the notary)	\$6
Additional signer (2 signers included in all services)	\$10
Uncertified copy of an entry from a notary's record book (per page)	\$0.50
Remote Online Notarization (includes first notarial act & signature)	\$31

ESCROW AND REAL ESTATE CLOSING PRICING

Single Loan Closing (15 miles of travel included)	\$150
Mileage fee per mile after first 15 miles	\$1
Printing of electronic documents (up to 200 pages)	\$25
Printing additional pages (per page)	\$25
Fax up to 15 pages	\$0.25
Cancellation Fee applied with 2-hours or less notice.	\$35
*Travel and non-closing fee. This fee is due if notary travels to location and borrower refuses to sign. Does not apply if signing is terminated due to documentation issues not presented by the signer	\$80

TRAVEL

Travel plus mileage	\$25
Mileage per mile	\$1
After hours 7:30pm to 9:30pm and Weekends	\$30
Late night (after 9:30pm) or Emergency	\$60
*For safety purposes all closings scheduled after dark will need to be performed at a public location	

LOCATION CHARGES

Hospitals and Nursing Homes	\$50
Jails and Detention Centers	\$75
IAH or Hobby Airport Terminal Fee	\$75
Excessive Wait Time (per hour more than 1 hour at location)	\$30
